- Office of Banganga Municipality Kapilvastu invites Sealed Quotations from registered eligible Suppliers/Bidders for the Supply, delivery and Installation of Solar street Light at different Places Banganga Municipality Kapilvastu as per the required specifications mentioned. Bidding is open to all eligible Bidders/Suppliers.
- Interested eligible bidders may obtain further information and inspect the Sealed Quotation (SQ) documents in English at the office of the Banganga Municipality Kapilvastu Nepal during office hours.
- Complete set of Bidding documents (SQ) in English may be purchased by eligible Suppliers/Bidders on the submission of a **Written Application**, copies of **Company/Firm Registration** and **VAT Registration** certificates and upon payment of a non-refundable fee of NRs. 1,000.00. The Sealed Quotation Documents shall be available for sale up to office hours till **12 Asad 2075**.
- Sealed Quotation for all tasks must be submitted to the above office on or before **12.00 Noon on 13 Asad 2075**. Documents received after this deadline shall not be accepted.
- Bids (SQ) must be valid for a period of 45 days, counting from the day of SQ opening and must be accompanied by bid security, amounting to minimum NRs. 33500.00 (In Words: thirty three thousand five hundred only), which shall be valid for minimum 30 days beyond the bid validity period. The bid security shall confirm to the standard format as specified in the bid document.
- If bidder wishes to submit the bid security in the form of cash, bidder has to deposit cash in deposit account no 3110303007103(Dharauti) A/C of Banganga Municipality Kapilvastu in Rastriya Banijaya Bank, Kapilvastu and submit bank deposit voucher along with the bid
- Received Sealed Quotations shall be opened in the presence of Bidders' representatives who choose to attend at **1.00 P.M. on 13 Asad 2075** at the office of Banganga Municipality, Kapilvastu Nepal. But nothing shall bar the opening of Sealed Quotations by the reason only that any bidder or its agent is not present. Bidder's representative should come with authorization duly signed by the authority of firm at the time of bid opening.
- If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
- Banganga Municipality shall not be responsible for any costs or expenses incurred by bidders in connection with the preparation or submission of bid (SQ). The bidders are advised to visit and assess the actual site conditions before submitting their bid (SQ).
- Banganga Municipality reserves the right to accept or reject, wholly or partly any or all the Bids (SQ) without assigning any reason, whatsoever.
- Those owners whose firm or company was blacklisted earlier with the provisions of Public Procurement Act, 2007 and if they have commenced business in the name of new firm or company are not allowed to participate in the Bid Proceedings.
